2017 Overdrive's Most Beautiful Contest

OFFICIAL RULES AND REGULATIONS

NO PURCHASE OR ENTRY FEE NECESSARY TO ENTER, PARTICIPATE OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS CONTEST IS NOT SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK OR ANY OTHER SOCIAL MEDIA SITE. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. DESCRIPTION: The Overdrive's Most Beautiful Contest (the "Contest") is a skill-based photo submission and essay contest. The Contest begins on Friday, December 16, 2016, and will culminate at The Great American Trucking Show in Dallas, TX from August 24-26, 2017 ("The Great American Trucking Show"). Entries, including nominations, will be accepted December 16, 2016, through February 15, 2017 (the "Contest Entry Period"). A panel of judges will determine the top ten (10) contestants (the "Finalists") and subsequently the first-place winner of the Contest, as described in Section 4 below (the "Final Round").
- 2. SPONSOR: Randall-Reilly Publishing Company, LLC, 3200 Rice Mine Road NE, Tuscaloosa, AL 35406. Sponsor reserves the right to modify, suspend, extend or cancel the Contest (with or without notice) at any time in Sponsor's sole discretion and may, but is not required to, substitute another contest in its place. Sponsor further reserves the right to amend or change these official rules and conditions of entry (the "Official Rules") at any time, in Sponsor's sole discretion.
- 3. ELIGIBILITY: This Contest is open only to legal residents of the fifty (50) United States and Washington D.C., and Canada, who are eighteen (18) years of age or older as of the date of entry and who are working drivers with a valid commercial driver's license in the state of the contestant's residence. Employees, directors, officers, agents, representatives and their immediate family members (including spouses, siblings, parents and children) and household members (whether related or not) of Sponsor, Overdrive magazine, or any of their respective parent companies, subsidiaries, affiliates, agents and companies involved in the design, implementation and execution of the Contest (the "Contest Entities") are not eligible to participate in this Contest. AGREEMENT TO OFFICIAL RULES: By entering the Contest, you fully and unconditionally agree to be bound by and accept all terms of these Official Rules and the decisions of Sponsor (including decisions with respect to the selection of winners and the interpretation of these Official Rules), which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all of the requirements set forth herein.

HOW TO ENTER: Each entry consists of an entry form and a single photographic image no more than one year old. To enter, visit www.overdriveonline.com/beautiful and complete the online entry form and follow the onscreen instructions. All entrants nominated by a second party will be e-mailed and verified prior to such nomination being entered in the Contest. All entry forms must be submitted by February 15, 2017, in order to enter the Contest. You must provide all of the information requested in the entry form and a photograph less than two years old in order to participate in the Contest. All entries become the property of Sponsor and will not be acknowledged or returned. By submitting your entry, you agree that the Sponsor, in its sole discretion, may remove your entry and disqualify you from the Contest if it believes, in its sole and absolute discretion, that your entry fails to conform to these Official Rules or it determines the entry to be inappropriate for any other reason. Sponsor further reserves the right to use any information submitted by any entrant in any form of media whatsoever without compensation, including as more specifically described in these Official Rules. Only those entries actually received prior to the end of the Contest Entry Period will be eligible to participate in the Contest. All times are measured by Sponsor's clock. Proof of sending is not proof of receipt; screen shots or confirming e-mails will not be accepted as proof of receipt. LIMIT ONE (1) ENTRY PER PERSON/PER E-MAIL ADDRESS. By entering the Contest, entrants agree to receive Overdrive magazine's digital newsletter via e-mail. Entrants who do not wish to receive e-mails from Overdrive magazine may opt out upon receipt of the first e-mail or any e-mail thereafter by following the opt-out instructions provided therein. - a. SIGNING UP: During the Contest Entry Period, complete the online entry form as described above. By clicking submit, you confirm that you (or the driver you are nominating) are a working driver with a valid commercial driver's license and have not previously been a Finalist in Overdrive's Most Beautiful contest.
- b. VOTING ROUND: There is no voting round for the 2017 Contest.
- d. FINAL ROUND SELECTION AND SELECTION CRITERIA: Judges will select 10 Finalists, and these Finalists will be subject to a background check. Sponsor, Overdrive magazine and judges reserve the right to disqualify any entry at any time in the event they determine, in their sole and absolute discretion, that the entry is offensive, inappropriate, not in keeping with Sponsor's or the Contest Entities' images, or that an entrant has not otherwise complied with these Official Rules. The Contest winner (the "Grand Prize Winner") will be selected by judges, determined by Sponsor in its sole discretion. The judges will judge the Finalists' entries based on the following criteria: (i) interviews with each of the finalists, and (ii) relevance and interest of the finalist's entry to Overdrive magazine readers. In order to be selected as one of the Grand Prize Winner, the contestant must be available to attend The Great American Trucking Show (airfare and lodging provided as described in Section 7 below).
- 5. If the Grand Prize Winner: (i) cannot be contacted within five (5) calendar days of first notification attempt, (ii) is unwilling or unable to attend The Great American Trucking Show, (iii) rejects her Grand Prize, or (iv) fails to comply with these Official Rules, the Grand Prize will be forfeited and the Sponsor may, but is not required to, select an alternate Grand Prize Winner.
